We are a specialist in civil engineering and HVAC supplies, especially pipes, drains, chambers and geotextiles.

PRODUCT DESCRIPTION

This EPD represents many durable non-woven geotextile products used for filtration and separation, manufactured in Finland from high quality polypropylene fibres. Six different fabric profiles are produced, five of them in accordance with the NorGeoSpec standard and one in accordance with VTT-GEO 93. Fabric rolls are available in various widths (2 to 6 m) and lengths (75 to 100 m), depending on the product.

The products offer excellent filtration properties, high water permeability and optimum soil retention, ensuring the performance of the fabrics even under high mechanical and hydraulic loads. UV stabilisation provides extended protection against direct sunlight. Product numbers covered by this EPD, separated by fabric profile:

MANUFACTURING AND PACKAGING (A1-A3)

The environmental impacts considered for the product stage cover the manufacturing of raw materials used in the production as well as packaging materials and other ancillary materials. Also, fuels used by machines, and handling of waste formed in the production processes at the manufacturing facilities are included in this stage. The study also considers the material losses occurring during the manufacturing processes as well as losses during electricity transmission.

The manufacturing process begins by opening and separating the densely packed polypropylene fibres. The fibres are aligned into a continuous sheet, folded and layered to achieve the desired width and weight per square meter. The sheet is needled in order to mechanically bind the layers together and calendered to enhance the surface. Batch-specific information is printed on the fabric, and the edges of the sheet are trimmed. The fabric is wound around a plastic tube, also manufactured by Meltex in Finland, and cut to the desired length. The roll is wrapped in plastic film, bundled with others using plastic strapping and lifted onto a wooden transport frame.

TRANSPORT AND INSTALLATION (A4-A5)

Transportation impacts occurred from final products delivery to construction site (A4) cover fuel direct exhaust emissions, environmental impacts of fuel production, as well as related infrastructure emissions.

A4: The typical transport distance from the manufacturing site to the construction site is 235 km by lorry, based on sales data. Vehicle capacity is assumed to be fully utilized as full loads are preferred and return loads are typically utilized. There is assumed to be no loss during transport.

A5: The product is typically installed in excavated ground, and the environmental impact of fuel used by machinery during installation is included. There is assumed to be no loss when installing the product. Waste packaging material handling, transport, recycling, and incineration are included. The release of biogenic carbon dioxide from the wood used for packaging is also considered.

PRODUCT USE AND MAINTENANCE (B1-B7)

This EPD does not cover the use phase.

Air, soil, and water impacts during the use phase have not been studied.

PRODUCT END OF LIFE (C1-C4, D)

C1: The product is typically excavated from the ground, and the environmental impact of fuel used by machinery during demolition is included. It is assumed that there is no loss during excavation. The end-of-life scenario is based on Plastics Europe (2018) data on polypropylene construction waste.








C2: The end-of-life product is assumed to be transported by lorry to the nearest facility, which is assumed to be 50 km away.

C3–C4: Based on Plastics Europe data, 50 % of the product is assumed to be incinerated, producing energy. 23 % of the product is assumed to be recycled, and 27 % is landfilled.


D: The benefits and loads of the end-of-life product and its packaging are considered, including conversion to recycled plastic and the heat and energy produced by the incineration of waste.








MANUFACTURING PROCESS AND SYSTEM BOUNDARIES









LIFE-CYCLE ASSESSMENT

CUT-OFF CRITERIA

The study does not exclude any modules or processes which are stated mandatory in the reference standard and the applied PCR. The study does not exclude any hazardous materials or substances. The study includes all major raw material and energy consumption. All inputs and outputs of the unit processes, for which data is available for, are included in the calculation. There is no neglected unit process more than 1% of total mass or energy flows. The module specific total neglected input and output flows also do not exceed 5% of energy usage or mass.

ALLOCATION, ESTIMATES AND ASSUMPTIONS

Allocation is required if some material, energy, and waste data cannot be measured separately for the product under investigation. All allocations are done as per the reference standards and the applied PCR. In this study, allocation has been done in the following ways:

The primary data represents 19 polypropylene geotextile products manufactured in Jyväskylä, Finland. Similar raw materials and processes are used in manufacturing the products. The amount of packaging varies according to the size of the geotextile fabric rolls. The variability in the environmental impact per kilogram of product is small, and this EPD represents an average of the products by production mass.

LCA SOFTWARE AND BIBLIOGRAPHY

This EPD has been created using One Click LCA EPD Generator. The LCA and EPD have been prepared according to the reference standards and ISO 14040/14044. The EPD Generator uses Ecoinvent v3.8, Plastics Europe, Federal LCA Commons and One Click LCA databases as sources of environmental data.
