### PRODUCT DESCRIPTION

This EPD represents a wide range of durable polyethylene (PE) pressure pipe products used for conveying water, drainage, and sewage. The pipes are manufactured in Finland from high quality materials. Some characteristics vary between the products: the material is either PE80 or PE100, the range of outer diameters is from 20 mm to 500 mm, and the pipe length is typically from 1 to 500 meters. The pressure class is from PN10 to PN16, and the wall thickness is from SDR11 to SDR17. The products are typically supplied with plugs for the pipe ends. Product numbers covered by this EPD:

### MANUFACTURING AND PACKAGING (A1-A3)

The environmental impacts considered for the product stage cover the manufacturing of raw materials used in the production as well as packaging materials and other ancillary materials. Also, fuels used by machines, and handling of waste formed in the production processes at the manufacturing facilities are included in this stage. The study also considers the material losses occurring during the manufacturing processes as well as losses during electricity transmission.

The manufacturing process begins with the melting of the raw materials: polyethylene granules, additives, and pigments. These are extruded into a single wall pipe with a smooth surface. The pipe is cooled by water in a closed loop system. Product and batch specific information is typically printed on the pipe. The pipe is cut to the required length, and plastic plugs are typically applied to the ends of the pipe. The packaging depends on the

dimensions of the product, and typically consists of a wooden pallet and plastic film, or a wooden frame and metal strapping. Some products are coiled. By-products from the manufacturing process are processed back into raw materials. All electricity used in pipe production is generated by hydroelectric power.

### TRANSPORT AND INSTALLATION (A4-A5)

Transportation impacts occurred from final products delivery to construction site (A4) cover fuel direct exhaust emissions, environmental impacts of fuel production, as well as related infrastructure emissions.

A4: The average transportation distance from the manufacturing site to the construction site is 227 km by lorry, based on sales data. Vehicle capacity is assumed to be fully utilized as full loads are preferred and return loads are typically utilized. There is assumed to be no loss during transport.

A5: The product is typically installed in an excavated trench or in a building, and the environmental impact of fuel used by machinery during installation is included. There is assumed to be no loss when installing the product. Waste packaging material handling, transport, recycling, and incineration are included. Release of biogenic carbon dioxide from the wood used for packaging is also considered.

### PRODUCT USE AND MAINTENANCE (B1-B7)

This EPD does not cover the use phase.

Air, soil, and water impacts during the use phase have not been studied.

### PRODUCT END OF LIFE (C1-C4, D)

C1: The product is typically excavated from the ground or removed from the building, and the environmental impact of fuel used by machinery during demolition is included. The end-of-life scenario is based on Plastics Europe (2021) data on construction polyethylene waste.

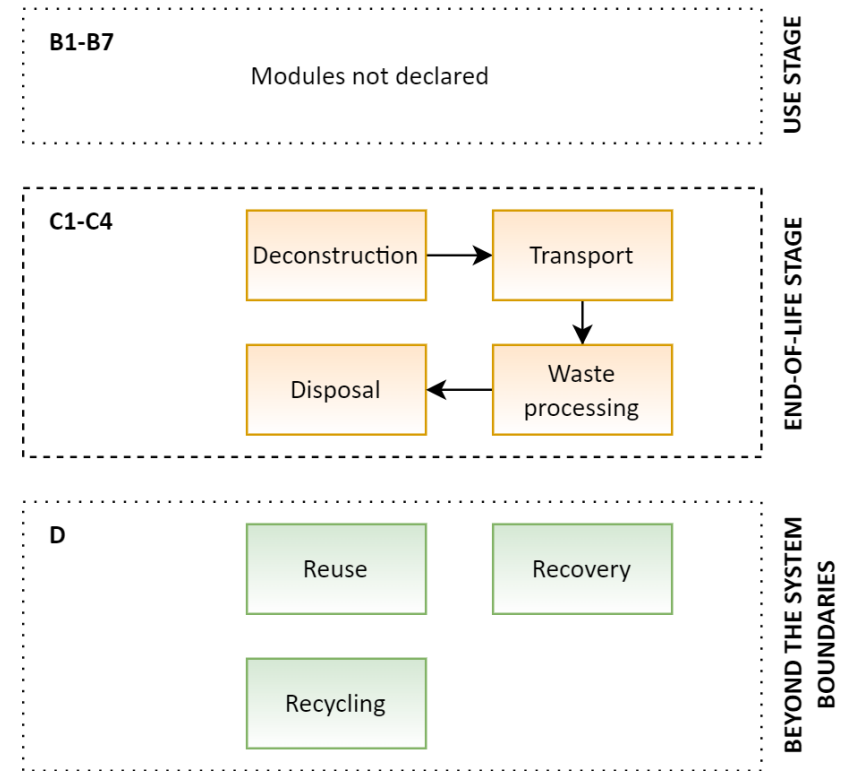
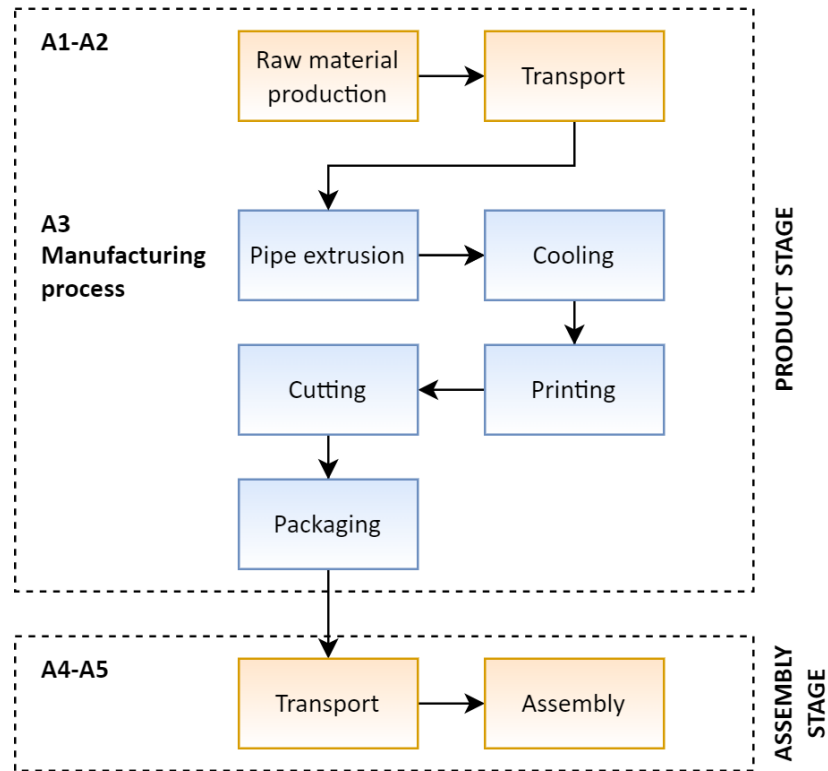
C2: The end-of-life product is assumed to be transported by lorry to the nearest facility, which is assumed to be 50 km away.

C3-C4: Based on Plastics Europe data, 49 % of the product is assumed to be incinerated, producing energy. 24 % of the product is assumed to be recycled, and 27 % is landfilled.

D: The benefits and loads of the end-of-life product and its packaging are considered, including conversion to recycled plastic and the heat and energy produced by the incineration of waste.

## LIFE-CYCLE ASSESSMENT

### CUT-OFF CRITERIA

The study does not exclude any modules or processes which are stated mandatory in the reference standard and the applied PCR. The study does not exclude any hazardous materials or substances. The study includes all major raw material and energy consumption. All inputs and outputs of the unit processes, for which data is available for, are included in the calculation. There is no neglected unit process more than 1% of total mass or energy flows. The module specific total neglected input and output flows also do not exceed 5% of energy usage or mass.

### ALLOCATION, ESTIMATES AND ASSUMPTIONS

Allocation is required if some material, energy, and waste data cannot be measured separately for the product under investigation. All allocations are done as per the reference standards and the applied PCR. In this study, allocation has been done in the following ways:

The primary data represents 89 plastic pressure pipe products manufactured in Kuhmoinen, Finland. Similar raw materials and processes are used in manufacturing the products. Although there are some differences in the features and the packaging of the products, the variation in the environmental impact per kilogram of product is small. This EPD represents an average of the products by production volume.

### LCA SOFTWARE AND BIBLIOGRAPHY

This EPD has been created using One Click LCA EPD Generator. The LCA and EPD have been prepared according to the reference standards and ISO 14040/14044. The EPD Generator uses Ecoinvent v3.8, Plastics Europe, Federal LCA Commons and One Click LCA databases as sources of environmental data.
